- (v) Chairman- National Board of Revinue (NBR) and related Member (NBR)
- (vi) Secretary, Power Division (MoP, E & MR).
- (vii) Secretary, Energy and Mineral Resources Division(MoP, E & MR)
- (viii) Chairman, Bangladesh Power Development Board (BPDB)

### Achievements of Bangladesh Independent Power Producers' Association:

Honourable members, I want to draw your kind attention to some of our achievements under the dynamic leadership of Mr. Mohammad Latif Khan, President (BIPPA).

#### 1. Opening of New office of BIPPA:

We have rented a new office space at Navana D.H. Tower, Suite-1602, 16<sup>th</sup> floor, Plot-6, Panthapath, Dhaka and started our official activities in the new premises on 29.02.2016. The activity of our Association has started in the new office with a Board Meeting.





## 2. <u>Compulsory Membership of Bangladesh Independent Power Producers'</u> <u>Association:</u>

As per request of Bangladesh Independent Power Producers' Association, Ministry of Commerce issued an ordinance vide a circular dated 25.02.2016 regarding Compulsory Membership of Bangladesh Independent Power Producers' Association(BIPPA).

Bangladesh Bank also circulated the Ordinance of Ministry of Finance on 16.03.2016 to the all concerned financial organizations to take necessary action accordingly.

- 3. Omission of rejection clause regarding fuel handling experience to bid in the tenders of ten (100 MW each) HFO based power plants.
- 4. The numbers of the members of Bangladesh Independent Power Producers' Association by this time increased to 43(forty three) which is also an achievement of BIPPA.
- 5. We have successfully participated installing a stall in the National Power & Energy Fair-2015 at Bangabandhu International Convention Center (BICC) and the National &Power Energy Fair-2016 at Bashundhara International Convention Centre (BICC).
- 6. It is noted that we have got the appointment of Honourable Prime Minister on 10 August, 2017. Our president along with the members of Board of Directors of BIPPA handed over Pay Order of TK 5,00,00,000 (five crore) to Honourable Prime Minister in favour of Father of the Nation Bangabandhu Sheikh Mujibur Rahman Memorial Trust, Prime Minister's Relief and Welfare Fund and Prime Minister's Education Assistance Trust.

### Future Plan of Bangladesh Independent Power Producers' Association:

- 1. More private power producers' to be included as the member of BIPPA.
- 2. Website of BIPPA is under construction.
- 3. Research and Development cell be created.
- 4. Panel lawyer to be appointed for the solution of legal matters.
- 5. Professional accounts person to be appointed to develop the software of Accounts and to do accounts works smoothly.
- 6. Vision to purchase a permanent office space for BIPPA.
- 7. Create fund to promote and encourage and finance to the technical development in respect of power sector of Bangladesh.
- 8. We are going to participate in the coming National Power & Energy Fair-2017. We will install a stall in the said fair.

#### **Audit Report and Accounts:**

The audit Report and Accounts for the year ended 30 June 2017 as audited by auditor M/S G. NABI & CO. is circulated for your kind perusal and approval. It is noted that the total received amount (including Contribution) of BIPPA for the financial year 2016-2017 is TK-7,81,67,829( seven crore eighty one lac sixty seven thousand eight hundred and twenty nine), total expenditure is TK-7,05,99,616 (seven crore five lac ninety nine thousand six hundred and sixteen), and Cash in Bank on 30 June 2017 is TK-75,68,213 (seventy five lac sixty eight thousand two hundred and thirteen).





### **Budget of Bangladesh Independent Power Producers' Association:**

The budget of BIPPA for the calendar year 2018 is also circulated for you kind perusal and approval. The budget of the calendar year 2018 is of total TK-1,53,43,813 (one crore fifty three lac forty three thousand eight hundred and thirteen).

### Abolishment of Multiple Taxation from Dividend Income.

Board of Directors present in the 8<sup>th</sup> Board Meeting unanimously decided to pursue the issue with the Secretary, Power Division as well as with the Chairman, National Board of Revenue (NBR).

We have also written letters to Chairman (NBR), Principal Coordinator (SDGs) to Honorable Prime Minister and to Honourable Prime Minister on this regard.

The issue is now under active consideration of Power Division and National Board of Revenue (NBR).

# <u>Platinum Sponsor Expenses of BIPPA at National Power & Energy Hackathon 2017 held on 19-20 April 2017.</u>

Board of Directors present in the 6<sup>th</sup> Board Meeting unanimously approved Platinum Sponsor Expenses of TK 40,00,000 (forty lac) at National Power & Energy Hackathon 2017 held on 19-20 April 2017 at International Convention Centre Bashundhara(ICCB).

# Election of the Federation of Bangladesh Chambers of Commerce and Industry (FBCCI).

Board of Directors present in the 6<sup>th</sup> Board Meeting unanimously decided to take part in the Election of the Federation of Bangladesh Chambers of Commerce and Industry (FBCCI) as general members of FBCCI. The 5 (five) nominated members of BIPPA -1. Mr. Mohammad Latif Khan, 2. Mr. Imran Karim, 3. Mr. Gulam Rabbani Chowdhury, 4.Mr. Annisul Huq and 5. Mr. Lt. Gen.(Retd.) Abdul Wadud as the representatives of Bangladesh Independent Power Producers' Association (BIPPA) in the General Body of the Federation of Bangladesh Chambers of Commerce and Industry (FBCCI) took part in the voting of FBCCI, held on 14 May 2017 in Bangabandhu International Convention Centre (BICC).

### Permission to import of HFO of Sulphur content 2% instead of 3.5%.

Board of Directors present in the 8<sup>th</sup> Board Meeting unanimously decided to talk to the Secretary, Power Division for permission to import of HFO of Sulphur content 2% instead of 3.5% so that the environment pollution from HFO based power plant is reduced.

We have also written letters to Chairman (NBR), Chairman (BPDB) on HFO for Power Generation.

There was a meeting between Honorable State Minister and a team of Directors under the leadership of President, BIPPA held on 13 November 2017. After discussion a letter was written regarding Specification of HFO for power generation addressed to Honorable State Minister. This issue is now under active consideration of Power Division.





### Stall booking in National Power & Energy Fair-2017.

The members of the Board of Directors present in the 8<sup>th</sup> Board Meeting unanimously decided to book a stall in National Power and Energy Fair 2017 and empowered Mr. Animesh Kundu, Director, BIPPA, to make necessary arrangement for the stall.

On behalf of the Association I would like to express my thanks and gratitude once again to Mr. Mohammad Latif Khan for reallocating the pavilion of Summit Power Limited in favour of BIPPA for National Power and Energy Fair 2016. We are hoping that the President will be kind enough to reallocate the pavilion of Summit Power Limited in favour of BIPPA for National Power and Energy Fair 2017.

### Increasing of Subscription fees of BIPPA.
